In addition to traditional counseling, The Village provides play therapy and attachment therapy for traumatized children, Eye Movement Desensitization and Reprocessing (EMDR) treatment for adult incest survivors, and inter-agency cooperative effort for the treatment of sexual abusers and their family members, and treatment for alcoholism and other drug dependency. Our professional counselors also provide groups and classes for depression and anxiety, anger management, children and divorce, parent education, and social skills for children. In addition to outpatient counseling, The Village provides Family Group Decision Making (FGDM) and Intensive In-Home Family Based Services (FBS). FGDM brings together the child,
